- Request for Proposal (RFP) official document that summarizes what we want for our money - board is required to undertake RFP process as per G8 purchasing policy and model on Town of Banff
- Sonia Zyvatkauskas added RFP materials in Basecamp with example of current one via Town of Banff to see how RFP takes shape and what it contains
- Can release publically or released to specific suppliers Sarah McCormack already has short list we can share directly with
- RFP would contain goals for work, wish list, scope of work, deliverables, due dates, budget limits, other expectations ie. desire to have community input in design, low VOC materials, WCB obligations of contractors etc.
- Forces organization to think though and describe project for consensus and creates buy in and creates a shareable document and provides a record of how to award and select supplier shows that we are responsible stewards of library funds
- Can always refer to RFP if there are any disputes
- Builds capacity of board for further RFP processes
- What is the approach for RFP process three options:
 - take all research material gathered by sarah and shape into formal RFP and send to short list of supplies and ask to make submission based on proposal - accepted practice for RFP's - will be a uniform approach
 - 2. use same parameters in RFP document to plug in with information we already have from designers to create hybrid document and ask them to fill in blanks and then sign off as true representation of what they would deliver requires more work for board and suppliers not a standard process and no recommended
 - 3. information gather material and put in comparative table and outline the differences and similarities to inform decision making process
- Is there a disadvantage of going with a formal RFP process? There isn't a disadvantage - a committee would need to be formed to draft this RFP.
- AD-HOC RFP committee will need to be formed to start crafting an RFP OR Sarah McCormack with proceed with option 1 above and will create the document with the materials she has based on the examples on Basecamp and the BD&P Committee will contribute and Sonia Zyvatkauskas offered to review the final draft
